pioneer The Pioneer Generation **Disability Assistance Scheme**

IN MARCH, the Singapore Government announced plans to roll out a Pioneer Generation Package to honour our elderly pioneers and help them lead active and fulfilling lives in the community. Included in the package is the Pioneer Generation **Disability Assistance Scheme.**

What is the Pioneer Generation Disability Assistance Scheme?

There are about 450,000 Pioneer Generation members in Singapore, and about 27,000 of them are expected to have at least moderate disabilities. The Scheme provides cash assistance of \$100 per month to those from the pioneer generation who have moderate or severe functional disabilities, which are defined as requiring assistance with at least three out of six common Activities of Daily Living (ADLs).

The Scheme, which will start in September 2014, aims to help these pioneers with the cost of long term care required for their disabilities. The cash assistance can be used to pay for any expenses, such as home care or nursing home services, medical bills, or household expenses, at the beneficiaries' discretion.

Who can qualify for the Pioneer Generation **Disability Assistance Scheme?**

An eligible pioneer: is 65 years old or older in 2014; was a Singapore citizen as at 31 December 1986; and requires help with at least three ADLs as assessed by a Singaporeregistered doctor. The ADLs are:

- Showering or bathing ٠
- Dressing
- . Feeding
- Toileting
- Transferring from bed to an upright chair/wheelchair, or vice versa
- Mobility

Functional assessment for ADLs

To apply for the Scheme, pioneers need to visit a doctor who is registered under Singapore Medical Council (SMC) for a functional assessment to be done using the Functional Assessment Report (Figure 1). The report can be picked up at community centres or clubs, hospitals and polyclinics, or downloaded from the Singapore Silver Pages (SSP) at http:// www.silverpages.sg.

GPs can expect public requests for functional assessment as early as this month. However, the majority of walk-in patients will only start doing so from June 2014, when application opens to the public.

Not all eligible pioneers require an assessment. They include those who are:

- Already on ElderShield, Interim Disability Assistance Programme for the Elderly, or are receiving the Foreign Domestic Worker (FDW) Grant. They will be informed of their eligibility by the administrators of these schemes before June 2014.
- Bedridden. These patients' application only requires a doctor's note.

While all SMC-registered doctors can conduct the functional assessment, a list will be published in the Agency of Integrated Care (AIC) and Ministry of Health's websites by 30 May 2014 for patients' reference.
