In Singapore, patients with disabilities — many being elderly — can tap on various government assistance schemes administered by different agencies. Patients who wish to apply for some of these schemes are required to consult doctors to assess their need for assistance in Activities of Daily Living (ADL) using a Functional Assessment Report (FAR). Often, these patients will turn to general practitioners (GPs) to do the functional assessment. All SMC-registered doctors can perform the functional assessment using the FAR.

To help GPs advise their patients better, here's an overview of the different schemes that patients with disabilities can apply for by sending the completed FAR together with the relevant scheme application forms.

FREQUENTLY ASKED QUESTIONS

How is the FAR used?

The FAR can be used across a number of schemes, and need only be filled once. You can advise your eligible patients to photocopy the completed FAR for submission to multiple schemes.

Where can GPs obtain a copy of the FAR?

Applicants should bring the FAR to your clinic. Forms can be obtained from AlCare Hub or downloaded from the Primary Care Pages. (https://www.primarycarepages.sg/FAR-form.aspx).

How much should I charge for performing the functional assessment?

The functional assessment is chargeable at all healthcare institutions including hospitals and polyclinics, regardless of the outcome of the scheme application. Currently, GPs usually charge for cost recovery. As a reference, the polyclinics and public hospitals are charging about \$35 for their patients.
