This presentation provides an overview and walk-through of the Singapore Medical Council (SMC) disciplinary process from inception (ie, the time a complaint is lodged with SMC against a medical practitioner) to its closure, whether by an acquittal or adverse findings made against the practitioner. This will then lead into a discussion of recent SMC appeal decisions by the Singapore Courts, providing insightful guidance as to the fair and just conduct of SMC disciplinary proceedings. Following the introduction to SMC's functions in the disciplinary process, the requirements of the medical expert in the Disciplinary Tribunal will be discussed. The role of the medical expert in a Disciplinary Tribunal will be illustrated with some SMC cases.
